- a) Application no 14/01572/NPA – Mrs J Shearman - Haytor Reach Poultry Farm, Kellinch Application for prior approval under part 3 class MB and paragraph N of the Town and Country Planning (general permitted development) Order 1995 (as amended), for change of use of barn from agricultural use to a dwelling. Cllr C Stacey has declared an interest and left the room. No objections from the Parish Council - proposed by Cllr T Brownhill and seconded by Cllr Mrs E Heaver with all in agreement.

This often leads on in turn to a simple ‘emergency plan’ listing the volunteers etc. There are other implications as well about how we can help and I’d be grateful for a chance to talk to you.

Just for information you should be aware that the developer has appealed the enforcement notice relating to Fairview Road and Moorland Avenue.

The council has agreed to sell the former Blacklers Garage site in Newton Abbot for the new University Technical College and the research done on the benefits for young people in Teignbridge has been published. The contract has been awarded and work will start shortly beginning with the decontamination of the site. It is expected that the college will open in Autumn 2015.

The councils countryside rangers have arranged a Bracken Bashing event at Orley Common on Saturday 21<sup>st</sup> June at 10 am. The Common is a continuously changing environment and requires constant maintenance and to that end the Rangers ask for help from villagers during the year to assist in keeping the area free from invasive species.

Chairman – Cllr B Clatworthy confirmed he would visit the field to look at these items.
